#### Erasmus + Programme has a general objective to promote European values in accordance with the Article 2 on the Treaty of Eropean Union:

The European Union is founded on the values of respect for human dignity, freedom, democracy, equality, the rule of law and respect for human rights, including the rights of persons belonging to minorities.

These values are common to the Member States in a society in which pluralism, non-discrimination, tolerance, justice, solidarity and equality between women and men.







#### In 2017, in the selection of projects, emphasis will be put on:

reaching out to marginalised young people, promoting diversity, intercultural
and inter-religious dialogue, common values of freedom, tolerance and respect
of human rights as well as on projects enhancing media literacy, critical thinking
and sense of initiative of young people

 equipping youth workers with competences and methods needed for transferring the common fundamental values of our society particularly to the hard to reach young people and preventing violent radicalisation of young people.







### **ERASMUS+ Youth – Eligible Actions**

- Mobility for young people and youth workers (under Key Action 1) promoting Youth Exchanges, European Voluntary Service and mobility of youth workers in cooperation with Partner
- Deadlines for applications: 2 February, 26 April and 4 October 2017 at 12:00

#### €37.3 million to boost economic development and resilience in the Eastern Partnership

Brussels, 19 September 2016

Five actions worth €37.3 million to support youth, SMEs, maritime safety and border management in the Eastern Partnership.

The EU is committed to delivering tangible results for citizens across the Eastern Partnership. The EU has continued to focus on the four priority areas identified in the Riga Summit held in May 2015: strengthening institutions and good governance; market opportunities; mobility and people-to-people; interconnections.

In this context, five new regional cooperation projects worth €37.3 million will support youth, SMEs, maritime safety and border management in the Eastern Neighbourhood:

- 1. EU4Youth (€20 million) will tackle youth employability, leadership and entrepreneurship through a variety of actions including capacity building, fellowships, support to policy dialogue as well as grants to organisations active in these areas.
- Integrating SMEs from the EaP countries into domestic and global value chains (€6 million): the programme will help integrate SMEs from the partner countries into domestic and global value chains, facilitating their access to new markets and boosting economic development.
- 3. Maritime safety, security and maritime environmental protection in the Black and Caspian Sea Regions (€4 million): the programme will support partner countries' ongoing efforts to implement the relevant international legislation, align their regulatory framework to EU legislation, and improve their performance. As a result, the maritime environment will be better protected and maritime transport safer.
- 4. Introduction of an Automated Intelligent Video-Control System at Road Border Crossing Point Novaya Huta Novi Yarylovychi at the Belarus-Ukraine Frontier (€0.8 million): the system will reduce the time needed to carry out customs and border guard formalities, and enhance the capacity of the countries to prevent and fight cross-border crimes.
- 5. ENI East Global Allocation 2016 (€6.5 million) will support the project cycle management in the Eastern Neighbourhood countries, including the preparation, monitoring and follow-up of programmes, as well as activities in the field of information and communication.







## **ERASMUS+ Youth – Eligible Actions**

- CAPACITY DEVELOPMENT (under Key Action 2)
- Organisations from Eastern Partnership Countries can directly apply for grants to Education, Audovisual and Culture Executive Agency (EACEA)
- Deadline for application: 8 March 2017 at 12:00 (midday Brussels time)
- Projects can start between 1st July and 31st December 2017 and last 9-24 months.





## Capacity development activities:

- activities encouraging policy dialogue, cooperation, networking and exchanges
  of practices in the field of youth, such as conferences, workshops and meetings;
- large-scale youth events;
- information and awareness campaigns;
- development of information, communication and media tools;
- development of youth work methods, tools and materials, as well as youth work curricula, training modules and documentation instruments such as Youthpass;
- creation of new forms of delivering youth work and providing training and support, notably through open and flexible learning materials, virtual cooperation and open educational resources (OER)





## **Civil Society Fellowships for Youth**

Inclusive and participatory projects will strengthen the capacity of youth organisations and youth workers to build constructive relations with a variety of partners, including public bodies and civil society organisations.

Selected young leaders – the "Fellows" – coming from the applicant organisations, will enhance their skills and competences in the field of policy development, through mobility activities and working in hosting organisations in the EU.

Activities have to involve transnational non-formal learning mobility activities, like, for example, mentorship schemes and job shadowing. As part of the project implementation, young leaders will also carry out small youth policy engagement projects upon return to their sending organisation.





## Partnerships for Youth Enterpreunerships

Projects will promote youth entrepreneurship education and social ntrepreneurship among young people through transnational non-formal learning projects based on multilateral partnerships between organisations working in the mentioned areas, including business.

Priority will be given to projects which offer practical solutions to social challenges present in the communities of origin and exploit the economic potential of the region also by involving the private sector

This type of project may also include mobility activities.







## **ERASMUS+ Youth – Eligible Actions**

- Involvement of young people and youth organisations from Partner Countries
  neighbouring the EU in the youth **Structured Dialogue** (under **Key Action 3**)
  through their participation in international meetings, conferences and events that
  promote dialogue between young people and decision makers
- Deadlines for applications: 2 February, 26 April and 4 October 2017 at 12:00 (midday Brussels time)





## **SALTO EECA** aims & objectives

- To raise visibility and awareness of the ERASMUS+Youth as an opportunity for international youth cooperation and capacity building of young people and youth organisations from EaP Countries and Russia
- To promote cooperation with the regions by supporting Erasmus+ Youth National Agencies and youth organisations in establishing contacts, building partnerships and improving knowledge about specific features of the regions
- To support the quality of international youth projects implemented within the framework of the Erasmus+ Youth
- To develop cooperation with state institutions and non-governmental organisations active in shaping youth policy in both regions with a special focus on recognition of Youth Work and Non-Formal Education
